**Question 71:** In the Monterey Community, explain the Monterey Building Unit Numbering System with examples.

- Building Unit Numbers are the first digit in 3-digit Unit Numbers (e.g., <u>2</u>04), or the first two digits in 4-digit Unit Numbers (e.g., <u>38</u>09.
- The last two digits of a Building Unit Number indicate which level of the building the condominium is located. Examples follows:
  - o If the last two digits of a Unit Number (e.g., 34<u>01</u>) is an Odd Number (e.g., 01, 03, 05, 07, 09, 11, etc.), the condominium is located on the ground floor of the building.
  - o If the last two digits of a Unit Number (e.g., 34<u>02</u>) is an Even Number (02, 04, 06, 08, 10, 12, etc.), the condominium is located on the upper floor of the building.
