Seasonal Changes

While we all may be celebrating the changes to cooler weather, we must keep in mind that just like humans, systems adjust to weather changes:

Hot/Cold Water in the Units: The plumbing systems in the Monterey community were installed in 1975-1980. The Hot water heaters are in 23 locations throughout the community. The hot water is piped to each unit through a complex system of lines. When the weather changes the ground temperature changes and so it may take longer to get water to the desired temperature. Similarly, in summer it may take longer to get cool water. The Hot water heaters are kept at a temperature of 120 degrees which is standard. From the base hot water heater, the water must travel some distance to reach your faucet. This may cool the water.

Heated Pools: 2 pools and the hot tub are heated. The pools are heated to 87 degrees, the hot tub is 102 degrees.

HOT TUB REPAIRS – The hot tub has undergone several major repairs over the last two months. We have replaced the plumbing system. Currently we are experiencing minor electrical issues and will be working to upgrade the electrical systems to get the whole system up and running again.

It is a violation of the LVCCMA Rule VI: 17 — "Battery chargers for electric vehicles which can be seen from the street are not permitted, any other exterior charges must be approved by the Board of Directors. Extension cords used to charge electric vehicles cannot be visible from the street and may not cross any common area element. No use of common area electrical outlets are permitted for any reason."
